Camp Policies

Please take a moment to read these policies. They were created with our customers in mind. We hope your camping experience will exceed your expectations.

- All Campers and guests MUST register at front office/welcome center. Unregistered guests/visitors will be asked to leave the park.
- Quiet Hours are from 10:00 PM to 7:00 AM (and will be enforced)
- No open fires on the grounds unless they are in the designated fire pits provided at each campsite. All fires must be extinguished before you leave your site and before you go to bed. (Please do not relocate the fire rings). No wood can be brought in from outside the park. Wood may be purchased at the Welcome Center.
- Welcome Center Hours: M-F 9:00 am. – 6:00 pm, Sat-Sun 9:00 am – 4:00 pm (hours will be posted and will change with the seasons or as necessary). There will be an emergency phone number posted at the Welcome Center at all times as well as an on-site Park Host.
- Check In/Check Out: Check in is 3:00 and check out is 2:00. If you would like to extend your stay, please contact the Welcome Center and we will do what we can to accommodate your request.
- One RV and 2 vehicles per site. Do not park in any area other than your assigned site. If additional parking is necessary, contact the Welcome Center.
- Fireworks are not permitted in the park.
- RV toilet paper is required – this may be purchased in the Welcome Center.
- Pets are welcome! However, they must be kept on a leash at all times. You MUST clean up after your pet. If you do not, you will be asked to leave the park. Disposable bags and containers are provided at the park. Owners of uncontrolled, barking dogs will be asked to leave. Do not leave your site with pets tied outside and unattended. If your dog is outside you need to be with it at all times. No pets on the playground please.
- Do NOT Leave Children Unattended! Do not leave your children anywhere by themselves. Please Do Not send small children to the bath house unattended!!
- Bath houses are provided for your use. Please be considerate and pick up any items that you bring with you.
- Any park property damaged by you or your guests will be charged to you upon your departure. If there is an excessive amount of cleanup required at your site, you will be charged a minimum of \$25.00 cleanup fee upon your departure.
- No washing of vehicles, trailers or boats is permitted.
- Please respect the PRIVACY of others and do not walk through occupied campsites.
- Generators are **Not Allowed** unless permitted by owners for a special reason.
- Bagged garbage should be deposited in the dumpster provided at the rear of the campsite area. Please Do Not leave any garbage on the ground – metal garbage cans are conveniently located throughout the park.
- Ask us if you are not sure how to properly connect to any of the utilities – this is not a good time for guess work! All water and sewer connections must be leak free!

- Keep your speed under 5 miles per hour while in the park!!
- There is to be NO SMOKING in any of the facilities (including bath houses).
- Winds can come up very suddenly so please don't leave your awning out or lawn chairs out if you leave the park. They may not be there when you get back and they could cause damage to surrounding campsites.
- It is the express right of Management to refuse service to any vehicle/camper, which, in the opinion of Management, is not in conformance with the overall level of quality and appearance of the park. We require all Recreational Vehicles to be a 2013 or newer or to be approved by Management based on quality and condition. This is strictly to keep our park looking clean and neat and an atmosphere of quality and comfort for our guests. All units must be covered by insurance.

Here at Made In the Shade RV Park, we strive to keep our guests comfortable and provide the best camping experience possible. The above policies are in place to ensure that can happen. Should you decide not to follow these policies, you will be asked to leave the park immediately. Management decisions are final and there are no refunds if you are asked to leave.

RV Sites

- Daily Starting at \$49.95
- Weekly (Save 15%!)Starting at \$229.00
- Long-Term (more than 2 weeks)..... Starting at \$125.00/wk + electric **

All RV Sites are full hookups; electricity (20/30/50), water, and sewer.

Tent Camping

- Daily (with electricity & water access) \$29.00
- Daily (without electricity & water access) \$24.00

Max 6 people per site. One vehicle per site.

***Special Event weekends require a minimum two night stay. Pricing may vary on holidays and special occasions. A 48 hour notice of cancellation is required to receive a refund of pre-payment less a \$25 administration fee. No shows without notification will NOT be refunded.*

Long-Term Stay Cancellations & No Shows: If you cancel a long-term stay reservation (more than 2 weeks) within thirty days or less of your scheduled arrival date, you will be charged a service fee of \$100. No shows will be assessed a \$25 service fee and \$100 cancel fee. If canceled more than thirty days in advance no fees apply.

Refunds must be requested no later than 7 days after your scheduled departure date. Refunds for bankcard payments will be issued as a credit to your bankcard. The refund will be processed within 30 days of receipt and approval.

LONG-TERM Guest Agreement

GUEST MUST READ AND INITIAL ALL SECTIONS OF AGREEMENT

Fees

Long-Term Fees (2 Weeks or longer) = \$125.00/week + tax + metered electricity (Includes 2 adults). No refunds are provided for early departures. No proration.

The long-term fee may be increased occasionally, but guests will be provided 30 days' notice in such cases.

Additional charges:

- Extra adult (18 and over) \$15.00/week | Extra child (17 and under) \$10.00.
- Maximum (5) persons per site. Maximum 3 adults per site. Maximum 3 children per site.

Deposits

Long-Term reservations (2 weeks or longer) require a deposit of \$200.00 to be paid in full at time of booking to hold a suitable RV site. Upon check-in a \$150 electricity deposit will be charged and held for the duration of your stay and applied to your final electricity charges due at the time of your departure. Final electricity charges in excess of \$150 will be charged to the credit card on file. If final electricity charges are less than \$150 the deposit balance will be refunded to the credit card on file, less any other charges due per this agreement, within 10 days after the end of paid long-term reservation and removal of all guest's belongings. If any guest's belongings are left on Made In the Shade property beyond the end of the paid reservation, the guest agrees to forfeit any remaining deposit.

Payments and Due Date

The first week's payment is due at the time the reservation is made. Thereafter the payment due date shall be every Monday. Guests must have a valid credit card on file at all times and agree to have the weekly fee automatically charged each week and the metered electricity charged on or about the 1st of each month to the credit card on file or pro-rated for the length of stay (a receipt will be e-mailed to you). If you prefer to pay the fee in cash you must pay prior to the due date. We do not accept checks. It is the guest's responsibility to provide Made In the Shade RV Park & Campground with updated credit card information as necessary. If a payment cannot be processed for any reason a \$10 fee may be added to your account for each day the payment is late.

Metered Electricity

An initial meter reading will occur on your arrival date. Thereafter meters are read and usage is billed on the 1st of each month (a receipt will be e-mailed to you). A final meter reading will occur on your departure date after you've departed. Your electricity deposit will be applied to the final electricity charge. Any additional amount due will be billed to the credit card on file. A refund will occur if the deposit exceeds the final charge. **INITIAL METER READING:** _____

Damages and Removal of Guest Property

Any costs incurred by Made In the Shade due to damages (e.g., damages to electrical pedestal, water spigot, sewer, fences, trees, picnic tables, fire rings, signage, grass, etc.) caused by guest or costs incurred by Made In the Shade for removal of guest's property will be charged to credit card on file and/or deducted from the remaining electricity deposit balance. Guest agrees to pay any additional costs incurred by Made In the Shade and will be billed if other payment methods are insufficient.

Mail & Packages

Guests may NOT change their permanent legal mailing address to Made In the Shade's address and establish domicile/residency. Guests may not fill out a change of address form with USPS and change their address to Made In the Shade's address. Guests may not obtain a driver's license with Made In the Shade's address. Guests may not have personal first class letters sent to Made In the Shade's mailing address. If you have a mail service, which we highly recommend, you may have it shipped here. Another option would be to obtain a P.O. Box in a nearby city. We are more than happy to accept packages from USPS, UPS, FedEx, etc. Packages are generally left in the Welcome Center. All packages sent to the park after your departure will be returned to sender unless specific arrangements are made.

Other Rules and Requirements

Guests may not store items outside of their RVs. Examples of non-allowable items are: refrigerators, freezers, upright storage cabinets, garbage cans, tools, and generators. Examples of allowable items are: camping chairs, small grills, rubbermaid storage containers that fit under the RV (no more than 3), and patio mats that are NOT on the grass. If you are unsure about an item please ask. Guests may not place any items on the grassy area of their site in a manner or for a period of time which will result in the grass dying.

Mowing — Guests are responsible for moving items off the grassy area of their site to facilitate mowing and weed whacking. **Please do not set up satellite dishes in the grass** as they will be in the way for mowing. You will be charged a \$20.00 fee for items left out that management is required to move in order to mow properly.

RV Washing — Guests staying more than one month are required and permitted to wash their RV's to maintain a clean appearance, not to exceed one washing per month.

Staying through the Winter — Guests planning to stay during any winter months (Nov-Mar) are requested to have an RV designed for below-freezing temperatures, often considered a "4 Season or All Season" RV and/or having an "Arctic Package" or similar. Guests are required to have a heated water hose. Made In the Shade will winterize the spigot on the guest's site using heat cable and insulation at guest's expense. Guests may keep the heat cable upon departure. Any damage to Made In the Shade property resulting from the guest's failure to properly winterize will be the guest's financial responsibility.

Pets — Long-Term guests must abide by our Pet Policy as stated in the Rules and Policies section on our website. Specifically, **Pets must be on a leash and supervised at all times**. Pets may not be left unattended outside of RVs. No pets are allowed in any buildings. All pet droppings must be picked up and disposed of properly. There is a \$10.00 fine if Management is required to clean up after your pet.

Driver's License — photocopy of driver's license is required and kept on file.

Duration of Stay Acknowledgment

This section is to indicate the intended duration of your stay.

Discontinuing Long-Term Stays

Long-Term guests who have elected to stay for longer than two weeks and are wishing to discontinue their stay at Made In the Shade RV Park are required to provide a 2 weeks' notice and their RV must be removed prior to the next payment due date. Failure to provide notice by the required time will result in a \$150 cancellation fee.

Made In the Shade Management may choose to discontinue any Long-Term stay for any reason, other than a violation of the rules and policies, with 2 weeks written notice via email, text, verbal or hand delivery. In such a case, guest will be permitted to stay only through the end of the current prepaid period.

Guest Ejection

Violation of any part of this agreement, or the rules and policies listed on our website at the website address below, can result in a guest being immediately ejected from Made In the Shade property with no refund.
